Legal basis for seminar participation:

These seminars deliver necessary information for EWC members to exercise their duties in an international environment. EWC members can request central management for time-off work and to cover seminar fees and travel expenses on the basis of article 10 (4) of the Directive 2009/38/EC, which stipulates: "In so far as this is necessary for the exercise of their representative duties in an inter-national environment, the members of the EWC shall be provided with training without loss of wages." Point 6 of the subsidiary requirements says: "Expenses of the European Works Council shall be borne by the central management." Similar rules apply to SE works councils. EWC members from companies which are subject to German legislation, are able to participate under the provisions of § 38 (1) of the German EWC Act.

Legal basis for participation to the seminars:
Article 10 (4) of the recast EWC Directive 2009/38/EC

We are holding our fifth EWC conference on 7th and 8th April 2016 in London. This time the agenda includes highly topical issues:

1. The United Kingdom EU membership referendum will take place on 23 June 2016. Will British EWC members lose their mandate should a majority vote to leave the EU? What would be the legal consequences for EWC agreements under British jurisdiction? See: <http://www.ewc-news.com/en022014.htm#4>

2. A verdict on European Works Council information and consultation rights was reached on 19 January 2016 in London. For the first time in legal history, the Central Arbitration Committee (CAC), the first instance labour court in British EWC matters, ruled that there had been a violation of EWC legislation (TICER). The EWC's lawyer will give a report on the case at the conference.

3. No later than 5 June 2016, the European Commission will present a report on the implementation of the (recast) EWC Directive and, where appropriate, make proposals for revising the Directive. The results of an evaluation study will be presented for the first time in London.
